22/194. To Update on Greening, Edgefield – A Parishioner has provided a letter with signatures to object to the proposed Greening Plans. It was mentioned that the petition has no names or addresses (only signatures) and is misleading. The Greening project will not be a cost to the Parishioners and will not be added to the precept. The Parishioner who has provided the petition stated that he did not mislead anyone into signing. It was mentioned that The Jubilee Playing Field is available for use for people under the age of 25. It was mentioned that no-one has come forward to meetings to object to the plans and it is too late now to turn back. A meeting was held on 8th December with NNDC, Cllr Andrew Brown and members of EPC were in attendance, for more details of the meeting please refer to the minutes on the website and on the Notice Boards. Cllr AB suggested Heads of Terms of Lease to be agreed rather than wait for the full lease so funding can be researched. The boundaries need to be looked into to determine who is currently looking after these.

It was also mentioned that the area around the Parish gates needs attention on both sides and there was recently flooding on Rectory Road. It was mentioned that we do not have a Grit Bin for use in icy weather, this could be used to store bags to be made into sand bags if required.
